Model 7655WCC barrier-free eye/face wash shall include an AXION® MSR eye/face wash head shall feature inverted directional laminar flow which achieves Zero Vertical Velocity™ supplied by an integral 4.2 gpm flow control, a fully recessed wall mounted 18 Gauge, Type 304 stainless steel deep-drawn cabinet, wheelchair accessibility, and polished chrome-plated brass pull-down valve with easy access in-line strainer. Unit shall also include brass pipe and fittings, a front-access maintenance panel, universal sign, 1/2" NPT(M) inlet. Operating pressure is 30 - 90 psi (2.1 - 6.2 bar).



## APPLICATIONS
