CONSTRUCTION

SPECIFICATIONS

Model 8356WCC barrier-free combination shower and eye/face wash shall include an AXION® MSR eye/face wash head shall feature inverted directional laminar flow which achieves Zero Vertical Velocity™ supplied by an integral 4.2 gpm flow control. Unit shall also include the AXION MSR hydrodynamic design stainless steel showerhead with 20 gpm flow control, a fully recessed wall mounted 18 Gauge, Type 304 stainless steel deep-drawn cabinet, wheel chair accessibility, and polished chrome-plated brass pull-down eye/face wash valve with easy access in-line strainer. Unit shall also include brass pipe and fittings, a drain pan, a front-access maintenance panel, universal sign, 1" NPT(F) inlet and 2" NPT(F) drain. Operating pressure is 30 - 90 psi (2.1 - 6.2 bar).

APPLICATIONS

Where the eyes, face, or body of any person may be exposed to injurious or corrosive materials, suitable facilities for quick drenching or flushing of the eyes, face, and body shall be provided within the work area for immediate emergency use. Emergency eye/face wash facilities and deluge showers shall be in unobstructed and accessible locations that require no more than 10 seconds for the injured person to reach. Model 8356WCC is certified by CSA to meet the ANSI Z358.1 Standard for Emergency Eyewash and Shower Equipment.




3. SHOWER MUST BE POSITIONED IN-LINE WITH EYE/FACEWASH HEAD TO ALLOW FOR SIMULTANEOUS USE BY THE SAME USER PER ANSI Z358.1.
